I believe that the overall plan is majorly outdated and certain pieces of information published within the plan are contradictory; with preliminary research dating back to 2014, the overall lifetime of this plan is 19 years. I understand that a plan like this, as stated in the Introduction & Context section, is required to illustrate the direction in which the council wishes to take the town, however 16 years of predictions, hopes and beliefs is borderline unproductive. What would be considerably more beneficial to the community and local businesses, in particular, would be a plan which has objectives which are then confined to time frames, which could then be re-examined, refined and re-thought when necessary and continuously.

The report states several ambitions for what the town will be like in 2033 but fails to pinpoint exactly how this will be executed, subsequently suggesting that improvements/changes will fail to materialize until the year 2033.

3.2 Ashbourne's Strengths; I would argue the wording on 'a superb range of independent, high-quality shops' is now outdated, with a rewording along the lines of - 'Superb independent retail and hospitality, which is varied but not extensive'.

The report holds onto various aspects such as Ashbourne Royal Shrovetide Football and the ever-failing market as a lifeline for the town, failing to illustrate that Ashbourne can expand itself and its inhabitants both culturally and traditionally, forming new traditions and events which will further entice tourists but most importantly give residents a feeling of pride for their town; an aspect which is substantially overlooked within the plan.

The word 'Bypass' is glorified throughout the plan of the saviour within the town, it is heavily suggested that if the Bypass is funded then the majority of problems within Ashbourne will be solved, unfortunately this is far from the case. Continuous traffic management is necessary in order to create a smooth traffic flow within the town and surrounding areas, whilst if the construction of the Bypass is permitted the town itself will have to try even harder to make the stop worthwhile. The construction of the bypass would, of course, have to be built without infiltrating any 'green zones' in order for the objectives of the plan to be met accordingly. Over the last 5 years, high streets across the UK have taken a dive, due to the increasingly popular e-commerce option, in section 5 it is highlighted that the "core retail leisure" must 'be protected and enhanced'. It will be interesting to see how this could be resurrected by 2033 as in 2020, the state of core retail, leisure both recreational and commercial is lacklustre, to say the least. With several shops standing empty, with little to no plans for these shops to be filled to create an interesting and worth-while highstreet which Ashbourne was once renowned for.

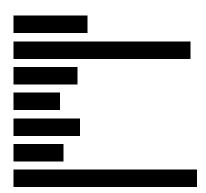

On behalf of Ashbourne Methodist Church (AMC) I want to express support for the wonderful and inspiring Vision and Aims of the Ashbourne Neighbourhood Plan and also to offer our support in tackling some of the issues identified in the SWOT analysis. At AMC we have been working on our Link Development Project for 5 years now. Working with Allan Joyce Architects and in extensive consultation with the national Methodist Church Conservation Officer and Trustees, with various heritage, environmental and other consultees and through the Pre-App process with DDDC Planners and the Environment Agency we now have a scheme which is ready to be submitted as a Planning Application. We have also confirmed with Planning Consultants that, in their view, the scheme is well fitted to support the Ashbourne Neighbourhood Plan.

As you know AMC is at the junction of Church Street and Station Road and comprises the church itself, Century Hall (with a further hall and accommodation underneath) and Cornerstone Cafe. Parts of the premises are listed, and the site is inside the conservation area. AMC propose to extend and remodel the church and attached hall to make them fit for the 21st Century, enabling a wide range of uses and community activities. Land to the rear of the church is to be redeveloped for housing to help fund the project. The whole scheme has been the subject of extensive pre-application discussion with DDDC Planners and has been amended to reflect the advice received.

The final scheme involves the sensitive insertion of new development in underused (and less attractive) areas within the grounds of the church. This will enable physical restoration of the church, hall and cornerstone cafe (including enhancing heritage features in the church), enabling the long-term use and maintenance of these buildings for the future. Adaptations are needed in order to provide level street access and a single primary point of entry from which different parts of the buildings can be easily accessed (including via lift and safe internal stairs). This is also safer from crime, safeguarding and Covid 19 prevention perspectives. The scheme will also provide flexible spaces and seating, better toilets and kitchens, resolve heating and ventilation issues, provide a mixture of smaller and medium sized rooms and also larger spaces for a greater range of community activities to take place. This will enhance its current significant use as a valued community asset which is used by a wide range of community groups, regardless of religious (or any) belief.

Continued maintenance and use of the AMC buildings will enhance the vibrancy of the town centre. We think it will be the largest public venue in town and can provide a service for concerts, performances and other public or private events with a variety of flexible spaces and seating. This will support the social health and vitality of the community and support the need to provide facilities to cater for the housing growth in the town. We plan to become a 7-day a week community centre providing a safe, welcoming, comfortable and flexible community asset.

Regarding the housing this is sensitively designed to subservient to the surrounding buildings and to provide smaller, low-maintenance apartments in a highly sustainable, brown field and town centre location.

We have previously presented to the Ashbourne Town Council Planning Meeting who have kindly been very warm and supportive of our proposals.

I just wanted to take this chance to offer our support for the Ashbourne Neighbourhood Plan and to both flag-up and commend our AMC Link Project as supportive to the Community objectives of the Plan.

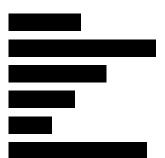
