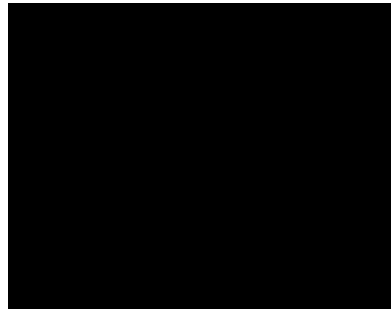

Why do the Maps showing existing employment sites exclude Ladygrove Mill ? This is a thriving employment site with existing users including a furniture making business and showroom ( Ashton and Coleman ), a vehicle repair garage ( Two Dales Garage ) ,Classic Gas Body Shop plus secure storage facilities and office accommodation . This brings attendant traffic problems and warrants attention in the Plan despite the fact that this site including the original Mill buildings has been allocated for housing in the past .Permission Ref 07/00876 /FUL . It is not clear to me whether this consent has lapsed through effluxion of time or whether there is an extant permission- see permission 11/00545/EXF . Either way this is a thriving employment site which seems unlikely to be redeveloped for housing in the Plan period . All this should be reflected in the NP.
