**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)**

The premises already operate as a restaurant and take away service. The application is being submitted to allow the premises to sell alcohol.

The team consists of both owners. Both of which fully understand the following:

- The challenge 25 policy including the forms of identification that are acceptable
- The hours and activities and conditions permitted in the premises license
- Action to be taken in the event of an emergency, including reporting an incident to the emergency services
- Maintaining an incident log.

**b) The prevention of crime and disorder**

No sale of alcohol to obviously drunk customers will be allowed.

An incident log shall be kept and maintained at the premises for production, on request, to an officer of a responsible authority. Records shall be retained on the premises for a minimum of 2 years.

**c) Public safety**

Health and safety measures in place

The collection of glasses, bottles and cans shall be undertaken at regular intervals to ensure there is no build-up of empties in and around the premises

There will be a first aid box and accident book

Everything in the building has been created to a high standard. Regular maintenance will be carried out.

**d) The prevention of public nuisance**

A telephone number shall be made available for neighbour's to contact us in the case of noise nuisance or anti-social behaviour by persons or activities associated with the premises.



**e) The protection of children from harm**

A challenge 25 policy will be in force, where any person looking under the age of 25 shall be asked to prove their age when attempting to purchase alcohol.

The only acceptable ID will be those with photographic identification documents; including passport, photo-card, driving license or proof of age card bearing the PASS hologram

An alcohol sales refusal register shall be kept at the premises and be maintained to include details of all alcohol sales refused.

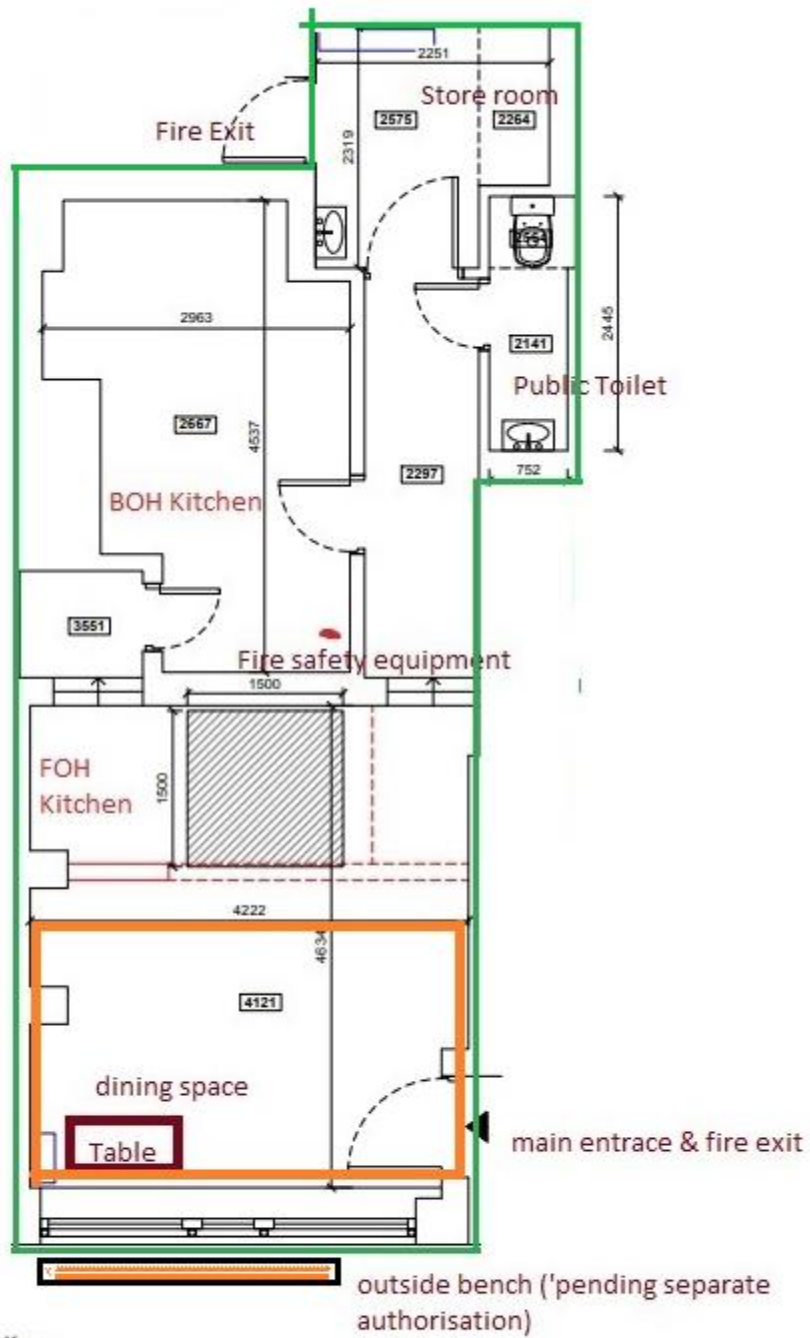
